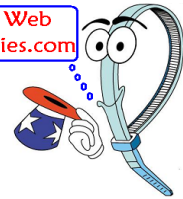

- 5) Please allow up to two weeks for any custom orders. This includes colors, packaging and labeling.
- 6) All orders are F.O.B Bay State Cable Ties shipping locations.
- 7) F.O.B free freight on orders is limited to the Continental U.S. It is limited to one release and shipping to one location. Bay State Cable Ties reserves the right to choice freight carriers on all free freight orders.
- 8) There will be a \$50.00 fee applied to any non-standard product documentation.
- 9) Bay State Cable Ties will not be responsible for any air freight due to errors. All air freight orders must be confirmed via fax or email prior to shipment.
- 10) Bay State Cable Ties will not be responsible for any International Customs charges which include but not limited to taxes, duties, tariffs, brokerage fees, storage fee, and freight charges. Unless otherwise specified UPS brokerage service will be used on all UPS Shipments.
- 11) **ALL PRICES AND POLICIES ARE SUBJECT TO CHANGE WITHOUT NOTICE.**
- 12) Invoice Late Fees & Interest Charge
 - A. Payments not received by due dates are subject to a 1.5% late fee per month.
 - B. Interest accrues from the invoice due date.
 - C. BSCT reserves the right to put a hold on any account past due.
 - D. All accounts will automatically be placed on hold if over 45 days from invoice date.
 - E. Checks returned unpaid subject to the maximum fees allowed.

- 1) No returns will be accepted unless accompanied with a written Return Material Authorization (RMA) from BSCT.
- 2) All requests for returns must be made within 60 Days of the purchase.
- 3) All returns are subject to a 15-35% restocking fee.
- 4) All returns must be in original package and sealed bags to be considered for credit.
- 5) No returns accepted on the following:

 - b) Private labeled products
 - c) Custom colors
 - d) Hot stamp orders
